Terms & Conditions

Please assign one person to be coordinator for your group. This will make things much less complicated. Please arrive 15 minutes in advance for your scheduled appointment to allow time to check in. We realize that time is of the essence and we do not want you to feel rushed in any way. Arriving early will ensure a stress-free experience. Hair should be shampooed no more than 24 hours prior to service unless otherwise specified by your consultant. For anyone receiving a specialty style, a button down shirt should be worn. For anyone receiving make-up services please arrive with a clean moisturized face. Be aware that this is a contract which requires a credit card to reserve all of your bridal and bridal party appointments. A 50% deposit of estimated services is expected at time of reservation to hold the days and times of your appointments. The balance is paid at the time of service. Please assign one person to pay the balance on the day of your services which will reduce confusion for your final transaction. We accept Cash, Debit, MasterCard, Visa, Discover, or American Express. Any changes or cancellations for any services within your appointment must be made with a 72 hours notice. "No -shows" or cancellations without 72 hours notice will be charged in full for services booked. A 20% gratuity will be included for all bridal services.
